General Rules and Regulations

- Attendees must be in grades 7-12, an adult chaperone, or a child of a chaperone
- **All** attendees must submit a registration form. Anyone under 18 must have a signed medical consent.
- Dress shall be modest at all times. The following are specifically not permitted:
 - Sleeveless, tank top, midriff, or low neckline shirts
 - Clothing with inappropriate words or images

Not Allowed

- Guns, fireworks, illegal knives, tobacco products, alcohol, or illegal drugs
- Pocketknives, electronic devices, comic books, and such like, except in the case of certain items, with the knowledge and specific approval of Tommy Johnson
- Disturbing the personal property of others
- Any display of affection beyond holding hands
